This unethical targeting of Constables not only undermines the voters and the authority they have bestowed upon their elected Constables, but also places a significant financial burdens on the taxpayers to fund the lawfare attacks on Constables, and a significant personal financial burden on the Constables themselves, as well as a waste of taxpayer money.

Taxpayer Burden

Constables impose minimal burdens on taxpayers, as they neither receive salaries nor have their office necessities or legal defense funded by taxpayers. However, the **lawfare** tactics employed against them are forcing Constables to bear the financial cost of defending themselves against these unfounded charges.
